- 1. *The Board will dispose the case of the children in conflict with law as per the procedure laid down under the Act and the Rules amended from time to time. Notwithstanding, the Board may adopt a set Rules of procedure in conformity with the Act and Rules for smooth functioning under intimation to the constituting Authority.*

2. *The Board shall meet at such times and shall observe such rules in regard to the transaction of business in its meeting, as may be prescribed and shall ensure that all procedure are child friendly and that the venue is not intimidating to the child and does not resemble as regular courts.*
3. *The Board will have jurisdiction over their respective administrative district.*
4. *The Board will have a tenure of 3(three) years from the date of issue of this Notification.*
