Integrated Child Protection Society (ICPS) chu naupang pualbil dan leh an nihlawhna leh hamthatna tura ruahmanna (scheme) zawng zawng luankhawmna a ni a. India ramah March 2009-ah din tan a ni a. Mizoramah chuan 2011-ah tihpuitlin a ni. ICPS thlen tum ber chu naupangte enkawlna tura an mamawh hrang hrang hmuh chhuah leh tihchak a, thawktute theihna leh thiamna tihpun leh thawktu hrang hrangte suihkhawma a zau thei ang bera mipuite hnena naupang dikna leh chanvo zirtir a ni a. A thurin leh innghahna bulpui ber chu: "PROTECTION OF CHILD RIGHTS" and "BEST INTEREST OF THE CHILD" tih a ni.

### CHILD WELFARE COMMITTEE (CWC) CHUNGCHANG

CWC chu Chairperson leh Member Secretary-te telin mi panga (5) an ni a. Member atan hian naupang lama thiamna sang nei leh tui mi, naupang dikna leh chanvo humhalh a, an hamthatna leh hmasawnna kawnga kum eng emaw ti chhung vantlang rawngbawl hna lo thawk tawh (social worker) te ruat tur an ni a, member zinga pakhat tal hmeichhia a ni tur a ni. A hun chhung hi kum 3 a ni a, a zawnin term hnih bak a chelh theih loh a. Hlawh leh hamthatna dang an nei lo va, Sitting Allowance an dawng thin a ni. Juvenile Justice (Care and Protection of Children) Act, 2015 Section 29 in a phut angin CWC hi Mizoroma District tinah din a ni tawh.

### CWC HNATHAWH

CWC Room chu naupang tan nelawm thei ang bera cheibawl niin, naupang leh a rawn hruaitute tlangnel taka an awm theih nan Committee member leh naupang leh a hruaitute ṭhutthleng inang veka thuin, inkawmhona pangngai taka neih thin a ni. CWC hian naupang emaw, an chhungte emaw, naupang rawn hruaitute emaw thusawi a ngaithla phawt a. Tichuan, District Child Protection Unit Staff, a bikin Protection Officer, Social Worker, Outreach Worker-te Home Investigation report behchhanin naupang tana tha ber tur ngaihtuahin thutlukna an siam thin.

### **CWC-IN A LO DAWNSAWN DAN TUR**

Naupang enkawl leh venhim ngai, CWC hmaa hruaite chu CWC chuan ngun takin a lo ngaihtuah ang a, an dikna chanvo chang tura humhalhna te, enkawl leh venhim ngaite chu him tak leh thlamuang taka enkawlna hmun, Shelter Home emaw, Children's Home emaw, mimal, naupang enkawl tura tling leh tlaka ngaihte hnenah a hun chhung biktukin a dah ang a. Chutah chuan an rilru leh thlarau dam nan mithiamte kaihhruinain a tul chen chen counselling an dawng ang a, counselling report atangin an tan tha ber turin an chungthu rel zui zel a ni ang. Tin, CWC chuan atuartu naupang aiawhin Police-ah FIR an theh lut ang.

### **CWC THUNEIHNA LEH MAWHPHURHNA PENG DANG**

**1) Sponsorship atan naupang Refer : ICPS hian naupang**

rethei leh tanpui ngai zual bikte tan Sponsorship Programme a kalpui a. Hemi atan hian CWC-in naupang tanpui ngai ngawih ngawiha a hriatte chu Sponsorship Approval Committee-ah a Refer thin a ni.

2) **Shelter Home leh Children's Home a naupang dah / lakchhuah :** CWC phalna lo chuan khawi Home-ah mah naupang dah luh leh lakchhuah phal a ni lo va, a tul tawpkhawk lovah chuan Home-ah naupang an dah ngai lo. CWC chuan Children's Home te hi a enthlithlai (monitor) reng a ni.

3) **Naupang baihvaite Foster Care-tu tur zawnsak:** Naupang baihvai, chhungte belh tur mumal nei lo emaw, a chenna in kha naupang thanlenna atan a him tawk lo emaw a nih chuan, hun eng emaw ti chhung naupang chu chhungkaw dangin an lo awmpui/enkawl lailawk (foster care) theihna turin naupang leh an chhungte dinhmun a zirin CWC hian Foster Care hun chhung a siamsak thin.

4) **Adoption :** Naupang chu amah hringtu nu leh pa ten an thihsan a, a thisen zawmpui dang enkawl theitu an awmlo emaw, an tlanbosan (abandon) emaw, an ngaihthaha an thlahthlam emaw, a hringtuin fa nihna an hauh thei loh vanga sawrkara a Surrender emaw a nih chuan mi dangin fa atan an la (adopt) thei a. Mimal leh mimal inkara fa inpek emaw, Children's Home atanga fa lak emaw, Damdawi Ina nau hringin a fa a tlanbosan a nih pawhin CWC thu lo chuan in pek ngawt a thiang lo a ni. CWC-in an tih tur ang an tih fel hnuah ICPS hnuia State Adoption Resource Agency (SARA) in Court lama chin fel ngai leh tul dangte an lo buaipui chhunzawm ve leh chauh a ni.

## NAUPANG CHU TU NGE?

United Nations Convention on the Rights of the Child (UNCRC) leh India rama naupang pualbil dan, Juvenile Justice (Care and Protection of Children) Act 2015 in naupang a tih chu nausen piang hlim atanga kum 18 la pumhllum lo chinte an ni.

## UN-CRC CHU ENG NGE ?

UN-CRC chu 1989 a khawvel sawrkar inzawmkhawm pawl, United Nation Organization (UNO) in a duan, naupang dikna chanvo thuthlung, United Nations Convention on the Rights of the Child a puan chhuah a ni a. UN-CRC zulzui hian UN Member ram ten an ram naupangte pualbil dan an siam tur a ni. Tunlai khawvelah UN-CRC hi naupang dikna leh chanvo lungphum pawimawh ber leh, ram hrang hrang tan pawha tehkhawng tling leh tlaka ngaih a ni a. Chuvangin UN chuan naupang dikna leh chanvo zawng zawng chu document pakhatah siamin UN document pawimawh ber zinga mi a ni.

## NAUPANG DIKNA LEH CHANVO BULPUI PALI

United Nations Convention on the Rights of the Child (UNCRC) in naupang dikna chanvo a tarlan pali te chu:

- 1) Nun khawchhuah theihna chanvo (Right to Survival)
- 2) Hmasawn thei tura chanvo (Right to Development)
- 3) Venhimna chanvo (Right to Protection)
- 4) Ngaihdan leh thutlukna siamnaa tel ve theihna chanvo (Right to Participation)

### JJA ACT 2015 HNUAIA NAUPANG CHUNGA DAN BAWHCHHIATNA PAWIMAWH ZUAL

● **Section 74:** Naupang, pawikhawihnaa inhnamhnawih emaw, misual pawikhawih tuartu emaw, thuhretu emaw, chhanchhuaha enkawl leh venhim ngai emaw reng rengte chu an nihna hriat theihna tilang thei tur chi, an thlalak, an hming, an nu leh pa hming, an khua leh veng hmingte thuthar thehdarhna hmanrua engahmah tiilan phal a ni lo va. Chutiang titu chu thla ruk (6) thleng lung in tantir emaw, cheng nuai hnih (2) chawitir emaw, a pahnih pawha hrem kawp theih a ni.

● **Section 75:** Naupang, a enkawltu tupawhin a ngaihthah lui emaw, a tihduhdah emaw, rilru leh taksa lama harsatna thlen khawpa a hlamchhiah emaw a nih chuan chutiang titu chu kum thum (3) thleng lung in tantir emaw, cheng nuai khat (1) chawitir emaw, a pahnih emawa hrem kawp theih a ni. Tisualtu chu naupang enkawl leh chhawmdawlina hmuna thawk an nih phei chuan hrehawm taka kum nga (5) thleng lung in tantir emaw, cheng nuai nga (5) thleng chawitira hrem theih a ni bawk. Hetianga naupang chunga tih a nih a, naupangin a rilru leh taksa lama rualbanlohma a neih phah phei chuan a enkawltu chu hrehawm taka kum thum (3) aia tlem lo, kum 10 thleng lung in tantir leh cheng nuai nga (5) thleng chawitira hrem theih a ni.

● **Section 77:** Naupang hnenah damdawi thiamte chawh ang ni lova zuemaw, vaihlo atanga siam chhuah emaw, ruihhlo eng pawh petu chu hrehawm taka kum sarih (7) thleng lung in tantir bakah cheng nuai khat (1) chawitira hrem theih a ni.

● **Section 80:** Naupang fahrah riangvai leh hlamchhiah vanga baihvaite enkawlina hmun, he dan hnuiai kaihruaina siam ang ni lova mimal emaw, pawl emawin an lo enkawlte mi dang hnena an pe a nih chuan chutiang titu chu kum thum (3) thleng lung in tantir emaw, cheng nuai khat (1) thleng chawitir emaw, a pahnih emawa hrem theih a ni.

● **Section 82:** Naupang chunga hleihluak taka hremna (corporal punishment) chelektu chu a vawi khatnaah cheng sing khat chawitir tur a ni a, a chelek nawn leh a nih chuan kum thum (3) thleng lung in tantir emaw, pawisa chawitir emaw, a pahnih pawha hremna pek kawp theih a ni.
