NAUPANG CHU TUNGE?

Juvenile Justice (*Care and Protection of Children*) Act 2015 in naupang a tih chu nausen piang hlim atanga kum 18 la pumhlum lo chin te hi an ni.

NAUPANG DIKNA LEH CHANVO PALI

United Nations Convention on the Rights of the Child (UNCRC) in naupang dikna chanvo a tarlan bulpui pali te chu:

- 1) Nun khawchhuah theihna chanvo
(Right to Survival)
- 2) Hmasawn thei tura chanvo
(Right to Development)
- 3) Venhimna chanvo *(Right to Protection)*
- 4) Ngaihdan leh thutlukna siamna a tel ve theihna chanvo *(Right to Participation)*

ICPS HI ENGE NI?

ICPS (*Intergated Child Protection Scheme*) hi Central Scheme a ni a, Juvenile Justice (*Care and Protection of Children*) Act, 2015 (*JJ Act*) behchhana siam a ni. Naupang harsatna tawkte dikna chârvo humhim saka, tha tak leh awmze nei taka an lo thanlen theihna atana hmun him leh boruak muanawm siamsak hi ICPS thiltum pawimawh tak a ni.

JUVENILE JUSTICE ACT LEH JUVENILE IN CONFLICT WITH LAW (NAUPANG DAN KALHA AWM)

Section 74 angin pawikhawihnaa inhnahnawih naupang emaw, pawikhawihna tuartu naupang emaw, thuhretu emaw, naupang chhawmdawl ngaite emaw chu an nihna tilang thei chi reng reng an hming, an nu leh pa hming, an khua leh veng, an thlalakte thuthar thehdarhna hmanruaah puanzar leh pholan phal a ni lova, chutiang ti te chu thlaruk (6) thleng lung in tan emaw, cheng nuai hniih thleng chawitir emaw, a pahnih emawa hrem kawp theih a ni. Police-te pawhin naupang nungchang tarlanna (Character Certified) atan naupang chungchanga thubuai chinfel tawh an phawrh tur a ni lo.

Naupang ten dān kalha thil an lo tih ve pawhin sual, thilsual ti (*Criminal*) anga ngai lovin, rilru lam chi-aîna vângä talbuai palh (*Conflict*) anga ngaia siam ṭhat leh hi dān hian a ngai pawimawh ber a. An pualbil dān hian an hmakhaw ngai tak zet leh an ṭhat theihna tur ang ber hi a zawn a ni a. An dikna leh chanvo humhalh sak chunga an ṭhanlen chhoh theih nana uluk tak enkawlna pawh an pualbil dān hian a ruahman tel vek a ni.

Dān hian naupang dān kalh a chete hi naupang an nih vângin a ngaidam ngawt lo va, naupang an nih vângin ngaihnathiamna thuk tak a nei a ni zawk. Naupang dān kalha chete Court rorelna hmaa ding lo va, Board/Committe hmaa dintir an nih zawkna chhan chu - thilsual an tih vângä an chunga Court rorelnaa hrem tuar tura thu-tihtluk (*Sentence*) lam ni lo va, siam ṭhat lam hawi zawnga an chungchang rel hi a tum ber a ni a. Board chuan dān kalha che naupang tana ṭha ber tur ngaihtuahin thutlukna a siam ṭhin a ni.

Naupang pualbil dan thar ber 2015-a hman ṭan, Juvenile Justice Care and Protection of Children Act, 2015 Section 15 angin, naupang kum 16 leh kum 18 inkar sual tawpkhawk leh rapthlak (heinous offence) a inhnamhnawih te chu, Juvenile Justice Board (JJB) hmaa hruai an ni tho ang a, JJB-in an chungchang uluk takin a lo ngaihtuah hmasa ang a, chu mi hnuah puitling anga Court pangngaia a thubuai ngaihtuah tha nia a hriat chuan Children's Court/Special Court-a an chungthu ngaihtuah zui turin a thawn ang.

JUVENILE JUSTICE BOARD (JJB)

Juvenile Justice Act 2015 Sec. 4 (1) angin naupang thilsual tite chungthu buaipui tur bik chu - 'Juvenile Justice Board' a ni a. Principal Magistrate, (*Magistrate 1st Class aia hniam lo a ni tur a ni a*) leh member dang pahnih, vantlang rawngbawl hnnaa inh mang mi, hmeichhia leh mipa an awm tur a ni. Tunah hian District zawng zawngah JJB hi din a ni tawh a. Case tam leh tlem dan a zirin an ṭukhawm ṭhin a ni.

He dān Section 15 (1)-na angin naupang dān kalha che ten pawi an khawih ngei a ni tih JJB-in a finfiah hnu chuan, a hnuai a mi ang hian thutlukna a siam thei ang.

- a) Tisualtu chu zilh emaw thurawn pein emaw inah a haw tir thei ang a, a nu leh pa emaw amah enkawltu, Guardian/Caregiver emaw, amah kum tling lo emaw chu Counseling a pe thei bawk.
- b) Tisualtu chu 'Group Counselling' emaw, chutiang lam thila tel turin thu a pe thei.
- c) Naupang chu khawtlang/vantlang rawngbawl hna thawh tur a tuk thei.
- d) Kum 14 a tling tawha pawisa a lak luh bawk chuan chawitir theih a ni a, a nu leh pate pawh chawitir theih an ni.
- e) Naupang chu a nungchang a ḥat chuan a chhuah thei ang a, nu leh pa tu emaw, Guardian emaw amah enkawltu thei tur emaw hnenah a dah thei. Mahse, kum thum aiin a rei tur a ni lo va, a awmna tur, nu leh pa emaw Guardian emaw amah enkawl thei tur chuan intiamna a ziak tur a ni a, Board hian intiamkamna (*Surety*) a phut thei.
- f) Naupang chu Special Home-ah a rei berah kum thum enkawl turin thutlukna a siam thei a. Mahse, JJB chuan a thiltihchhan chu chiang taka ziakin a dah tur a ni.
- g) Naupang chu enthlakna hnuaiah chhuah zalenin kum thum aia rei lo eng fit facility hnuaiah pawh a nun siamthat nan leh ṫha taka a nun chhoh theihnan a dah thei.

SPECIAL JUVENILE POLICE UNIT (SJPU)

Naupang thil tisuala puh man, Police Lock-up a dah lo va, hmun ralmuang leh him (*Place of Safety*) a dah tur a ni. Naupangin thil an tisual ve ṫhin, naupang an nih vāṅga man loh tur an ni lo, man an nih veleh S.J.P.U. hnenah hlan vat tur a ni a. S.J.P.U. te chuan naupang tana hmun him leh ralmuangah an dah ang a, darkar 24 chhungin JJB-ah an hruai tur a ni. (*Darkar 24 tih hian hmun hla zawka mi man in kalkawnga hun an sen hun chhung a huam lo*)

Tin, S.J.P.U. ten naupang dān kalha che an man reng rengin an manlai chauhin Uniform, Police kawr-uk an ha thei a, kutkawl leh kekawl an buntir tur a ni lo va, J.J.B. leh an tana hmunhima an hruaina velah chuan, thawmhnaw pangngai, *Civil Dress* inbelin engti zawng mahin naupang an rikrāp tur a ni lo va, an thiltihsual dawpchhuah tuma tharum hmanga sawisak leh vuak phal a ni lo.

Tichuan, naupang thil tisualte chu an pualbil dān chuan, khuahkhirh an nih pawha dimdawi taka enkawl tur a ti a, dimdawi taka enkawltu tur chu Sorkar, dān kengkawhtu leh khua leh tuite kan ni. Naupang, an seilenna boruak zir loh vāṅga nun kawng zawk palhte tana ruahmannna neih hi khua leh tui mitin mawhpfurhna a ni.



OBSERVATION HOME & SPECIAL HOME

Observation Home : Naupang dān kalha che te dah lailawknna hmun a ni a, Observation Home-a dah an nih chuan an chungchāng ngaihtuah hun chhung chauh an awm tur a ni a, a rei berah thla li (*4 months*) aia rei an awm tur a ni lo. Observation Home a a awm chhung hian JJB chuan Naupang awm zel dan tur chu a relfel hman tur a ni.

Special Home : Zirchianna (*Enquiry*) lak zawk a nih a (JJB-in in lama hawntir mai emaw, naupang lam enkawl thiamte hnena Counselling la zui tura tih ni lo), dān kalha chetna liantham deuh, nungchang siamthat nana hun duh rei deuh chi naupang an awm a nih chuan, Special Home-a enkawl zui turin thuchhuah a siam thei. Naupang chu Special Home-a dah a nih pawhin a rei berah kum thum (*3 yrs.*) aia rei a awm tur a ni lo.

NAUPANG NGAIHHNATHIAMNA

Naupan laia thil tisual tam zawkte hi enkawltu mumal an neih loh vang leh an chhehvel boruakin a zir loh vang a ni tlangpui a. Chuvangin, dan chuan ngaihhnathiamna thuk tak a pe a, nun kawng dik zawk leh tura siamthat leh theih an ni tih hi an pualbil danin a hriatchian ang tluka mitinin kan pawm tlan pawh a ngai a ni.
